NOTICE TO THE HOLDER OF THIS CERTIFICATE

1. If you change your normal place of residence from the one last recorded in this certificate you must report the change to the police within 7 days of your arrival at your new address.
2. A TEMPORARY absence of 2 months or less from your registered address need not be reported but if you are away for more than two months you must report to the police of the district in which you are registered your address at that time, any subsequent changes of address and your return home.
3. You must report within eight days to the police in the district in which you are registered ANY CHANGE in the particulars recorded in this certificate relating to name, marital status, nationality, passport or other document establishing identity and nationality, employment, business, profession, occupation.
4. Changes may be reported by letter, enclosing this certificate.

Failure to comply without reasonable excuse with any of the above requirements,

making any false statement to a person carrying out registration duties,

failure to produce the certificate when required to do so by an immigration or police officer,

having in possession or using without lawful authority for the purpose of the Immigration Act 1971 any forged, altered or irregular certificate, passport or other document

will render the offender liable to a fine of up to £200, or to imprisonment for up to 6 months, or both.
